



Privacy policy for customers and suppliers

Dear Customer and Supplier

Pursuant to and for the purposes of art. 13 and 14 of the EU Regulation on the processing of personal data, customers and suppliers are informed that as Data Controller,

holds and processes personal data protected by the aforementioned Regulation.

We remind you that according to the indicated legislation, this treatment will be based on principles of correctness, lawfulness and transparency and protection of your privacy and your rights.

In compliance with articles 13 and 14 of EU Regulation 679/2016, therefore, we provide you with the following information.

The data you provide will be processed for the following purposes:

- to fulfill obligations established by law and / or by community legislation
- allow the administrative / accounting management of the company
- allow management of the purchase of goods and services for business purposes
- allow the sale / rental / billing of products and / or the provision of services through direct contact with the customer or via the internet.
- perform obligations deriving from the contract between the parties
- manage any complaints and disputes

The treatment has a legal basis linked primarily to the fulfillment of the contract between the parties, compliance with the law and satisfying a request from the interested party.

The treatment will be carried out in the following ways: manual, IT and telematic, in compliance with the rules of confidentiality and security provided by law.

The provision of data is mandatory for the purpose of opening and managing contracts, and necessary to satisfy any requests of the interested party (technical, commercial information, etc.). Any refusal to provide such data could result in the failure or partial execution of the contract, and / or the failure to continue the relationship.

The data may be communicated, to execute the contract and to carry out the related administrative activities, to specifically appointed collaborators and employees. The data may also be communicated to third parties, during the execution of the obligations established by law or by the existing contract between the parties (e.g. Public Bodies, Supervisory Authorities, Banking Institutes, etc.). The data may also be communicated to associated and / or controlled companies, also outside the EU, always within the scope of the supply and / or contract in place. The data will not be disclosed to third parties in any way without your prior and specific consent. The data will in no way be transferred to third countries outside the EU.

Personal data will be kept for the time deemed useful for the execution of the requested service or for the management of administrative activities and tax, accounting and regulatory obligations.

At any time you can exercise your rights towards the data controller, pursuant to EU Regulation 679/2016, articles 15 to 20. The interested party has the right to obtain confirmation of the existence or not of personal data that concern and their communication in an intelligible form. He also has the right to obtain an indication of the origin of the data, the purposes and methods of treatment, of the Data Controller and Representative subjects, of the subjects to whom the data can be communicated. The interested party has the right to rectify, integrate, update the data, as well as to obtain the cancellation or transformation into anonymous form. The interested party can request the cessation of the treatment of direct marketing activities, commercial communications, market research at any time.
